The undersigned, ENSYRO SRL, registered with the Trade Register under no. J12/4147/2004, with CIF RO 16948082, headquartered in Gilău, DN 1 – E60, Balastierei Street, no. 1N, Cluj County, represented by General Manager, Mr. Coman Petru, issues the present

**Public environmental information, related to the first quarter of 2026, regarding the impact of the specific activity of ENSYRO SRL on the environment, in accordance with the provisions of art. 26, paragraph (1) of Government Decision no. 878/ 2005 on public access to environmental information.**

ENSYRO SRL, whose main activity is the manufacture of ventilation equipments, CAEN code Rev.2 – 2825, informs the interested public of the following:

- The company holds and maintains the requirements of Environmental Authorization no. 277/ 22.11.2022, revised on 15.05.2024;
- The collection and transport of hazardous and non-hazardous waste for the purpose of recovery/ disposal is carried out on the basis of contracts in force with authorized operators;
- In the context of waste generation and management, the company Ensyro SRL collects each waste by category in appropriate containers until it is handed over to authorized operators;
- Waste management records are maintained appropriately at company level, complying with the requirements of GD 856/ 2002. The company prepares the reports required by the environmental authorization and waste legislation (reporting of waste, packaging and packaging waste);
- ENSYRO SRL has implemented the Quality Management System (QMS) in accordance with the requirements of the ISO 9001:2015 standard certified by TÜV AUSTRIA, valid until 18.05.2026;
- ENSYRO SRL has implemented the Environmental Management System (QMS) in accordance with the requirements of the ISO 14001:2015 standard certified by TÜV AUSTRIA, valid until 08.12.2027;
- ENSYRO SRL employees are periodically trained on waste management and the impact of the activity carried out on the environment;

- The company Ensyro SRL is registered in the National Register of EEE producers for the purpose of introducing electrical and electronic equipment of type 4a and 5 on the market, with the number RO-EEE-5588-2024-06-06, having concluded a contract with the Environ Association to achieve the objectives set out in the EEE / WEEE/ AFM legislation;
- The company introduces packaging on the national market (through EU import/purchase of raw materials and own products, but also through the sale of its own products in Romania), as well as EEE, making monthly declarations to the Environmental Fund; the achievement of the objectives for packaging is done individually, and for EEE through the transfer of responsibility;
- A SMETA 4 Pillar audit was conducted in September 2025 by Bureau Veritas audit company. The audit included labour, health and safety, environment and business ethics standards and it was closed without non-compliances.
